Global Positioning / Electronic Monitoring Requirements for Supervision

The following is the participation agreement and requirements pertaining to your supervision. This Program is a condition of your bond and any violation of these rules may result in revocation of your bond.

1. You agree to follow all the court ordered standard conditions and any additional conditions of your bond.
2. You must call your Pretrial Officer immediately if there are any questions or problems with the rules and/or equipment.
3. You must adhere to the schedule as set by the Court or your Pretrial Officer.
4. You must not enter any exclusion zones as predetermined by the Court or your Pretrial Officer.
5. You must respond immediately to the Pretrial Officer if a message is sent via the equipment or telephone.
6. You must follow procedures as explained by your Pretrial Officer regarding emergency situations, and you must provide written verification of the emergency.
7. You agree that your employer may be called if you do not work at a fixed location.
8. You understand that all information gathered through the use of global positioning is stored as an official record and may be used as evidence in court.
9. You must not tamper with the equipment.
10. If the equipment you are using is damaged you are responsible for those damages and you may be charged with criminal mischief.
11. If the equipment is not returned you will be charged to replace that equipment and you may be charged with felony theft.
12. You will be charged a daily monitoring fee of \$ _____ (_____/_____) per day, to be paid weekly. Failure to pay that fee will result in revocation of bond.
13. You will forfeit all payments made if your bond is revoked.
14. At the time of successful termination from the program any surplus fees paid will be refunded.

I will abide by all terms and conditions set forth in this Agreement and all subsequent conditions as ordered by the Court or by Pretrial Services as part of my pretrial supervision. I understand that violation of this Agreement may constitute a violation of bond and a warrant may be issued for my arrest and/or additional charges may be filed. This agreement shall remain in effect until further order of the Court. I hereby authorize Pretrial Services / Electronic Monitoring Program to exchange information with other agencies of the City and County of Denver, the Second Judicial District, any law enforcement agencies outside the City and County of Denver and any Judicial Districts outside the Second Judicial District that may have interest in or be associated with this case. I have been advised that information regarding my current charge and the circumstances of my case are not to be discussed with my Pretrial Officer. Any information that is provided to the Pretrial program regarding my current charge may be provided to the Court. I also understand that any questions I may have regarding the status of my case should be discussed with my attorney rather than my Pretrial Officer. I do hereby for myself, my heirs, and administrators waive and release any and all claims, demands, damages, actions, liabilities, causes of action and/or suits of any kind or description whatsoever, including but not limited to injuries, known and unknown, to persons and/or property, that I may have against the City and County of Denver, the Second Judicial District of the State of Colorado, and any of their respective officers, agents, servants, employees, contractors, successors, and assigns, including but not limited to claims, demands, damages, actions, liabilities, causes of actions, and/or suits, caused in whole or in part by the negligence and/or breach of any duty and/or warranty by all or any of the above named persons or entities, in any way connected with this Program.
